CLAIM FORM INSTRUCTIONS

You may submit a claim form if you purchased a Class Product, for personal use and not for resale, before May 04, 2026. This Settlement does not release claims for personal injury or property damage and does not limit any rights under the Pool Recall.

Class Products include Bestway-branded pools 48 inches in height or taller with compression straps located outside of the support poles, sold between 2008 and 2024. **You must have purchased the pool from a retailer and not second-hand.**

If you are a Settlement Class Member, you are eligible to submit a Claim for a Cash Payment. **Only one claim is allowed per Settlement Class Household**, which is defined as a Settlement Class Member together with all Persons sharing the same residential address.

To obtain a Cash Payment, you must timely submit a completed Claim Form signed under attestation and provide the information listed on the Claim Form. **Claims submitted with Valid Proof of Purchase are eligible for a Cash Payment equal to 10% of either: (i) the actual price paid, as reflected in the Valid Proof of Purchase (e.g., receipt); or the Average Retail Price of the identified Class Product if no actual purchase price is reflected in the Valid Proof of Purchase. Claims submitted without Valid Proof of Purchase are eligible for a Cash Payment equal to \$40.**

Valid Proof of Purchase means objectively verifiable documentation showing purchase of a Class Product on or before May 04, 2026, subject to verification by the Settlement Administrator. Examples may include, but are not limited to, store receipts, online purchase receipts, or any other contemporaneous record of purchase that is objectively verifiable.
